VOTES ACT

Voter Registration Deadlines:

- Voter registration deadline for ALL elections/town meetings: 10 days
- Last Day to Register In-Person Sessions:
 - 1,500 voters or more: 9am-5pm
 - Less than 1,500 voters: 9am-11am and 3pm-5pm

Vote by Mail Overview:

- Early voting by mail is now required for all elections
 - Includes: primaries, state elections, and municipal elections
- Voters may apply to vote by mail for all elections in a calendar year

Vote by Mail Applications:

- Any written communication is sufficient
- Can sign by hand or electronically
 - Electronic signature: written substantially the same way as by hand
- Must include vote by mail applications with all acknowledgment notices to:
 - Newly registered voters
 - Voters who change their address
- Family members can apply for an EV ballot
- Application must be posted on city/town website

Vote by Mail SOC Applications and Portal:

- SOC will mail applications at least 45 days before every regular state primary, state election, and presidential primary
- Applications are pre-addressed to LEO and postage pre-paid
- Include voter ID barcode
- Application is for any election on primary or election date or all elections during the year
- SOC will establish online ballot request portal
 - Additional information will be forthcoming

Vote by Mail Application Deadlines:

- Deadline to receive application for mailed ballot: 5pm on 5th business day before election
- 2022 Deadlines:
 - September 6 – 5pm on Monday, August 29
 - November 8 – 5pm on Tuesday, November 1
- Deadline applies to both AV and EV mail-in ballots
 - Voters who qualify can still request an “emergency” absentee ballot

Vote by Mail Mailing and Receiving Ballots:

- Return ballot envelopes (AV-8s) are pre-addressed and postage pre-paid
 - Used for both AV and EV
- Ballots must be received by close of polls for most elections
 - Biennial state elections: Ballots mailed by Election Day can be accepted until 5pm on 3rd day after election
 - November 8 election deadline: 5pm November 12th
- Ballots can be returned by voter or family member
 - In Person at clerk's office
 - In Person at EV location during EV hours
 - Drop Box
 - Mail

More on mailing and receiving ballots on Thursday, July 21st at 10AM

Vote by Mail Other Changes:

- Advance removal and depositing
- A voter's ballot can be counted as long as the voter was alive when it was cast
- Accessible Vote by Mail
 - Voters with a disability preventing them from marking a paper ballot independently may request accommodation
 - Additional information will be coming soon



In-Person Early Voting:

In-Person Early Voting Dates:

- In-person EV must be offered for all regular state primaries, state elections, and presidential primaries
- In-person EV for state and presidential primaries: 10th day before through 4th day before primary
 - September 6, 2022 EV Period: August 27th – September 2nd
- In-person EV for state elections: 17th day before through 4th day before election
 - November 8, 2022 EV Period: October 22nd – November 4th

In-Person Early Voting Hours:

- Weekday hours:
 - Under 5,000 voters: at least 25% of usual business hours
 - 5,000 – 40,000 voters:
 - 15th – 11th day: at least 50% of usual business hours
 - 8th – 4th day: during usual business hours
 - Over 40,000 voters: during usual business hours
- Weekend hours:
 - Under 5,000 voters: at least 4 hours a weekend, 1 day per weekend, at least 2 hours when open
 - 5,000 – 24,999 voters: at least 6 hours a weekend, 1 day per weekend, at least 3 hours when open
 - 25,000 – 39,999 voters: at least 4 hours each weekend day
 - 40,000 – 74,999 voters: at least 6 hours each weekend day
 - 75,000+ voters: at least 8 hours each weekend day
- You may provide additional EV hours if desired

In-Person Early Voting Locations:

- Must include local election office, unless determined to be unsuitable or inaccessible
 - If unsuitable/inaccessible, must identify alternative centrally-located, suitable, and convenient public building within city/town as EV location
- City/Town can provide for additional early voting sites
- Each EV location must be accessible
- Must be designated at least 14 days before EV period starts
 - September Primary: August 13
 - State Election: October 8

In-Person Early Voting Notice:

- Must publish notice of locations and schedules for EV:
 - At least 5 business days before EV starts
 - State Primary: August 22
 - State Election: October 17
 - At least once during EV period
- Notice must be posted:
 - In your office or on city/town bulletin board
 - Any other public building considered necessary
 - On city/town website
 - On SOC website – must enter into VRIS (or email if VRIS is locked)

In-Person Early Voting 150 Foot Rule:

- 150 ft. rule prohibiting campaigning at polling places is extended to EV locations as of September 6 primary
- No campaigning for or against candidate or question on ballot within 150 feet of entrance to EV location during EV hours
- No signature gathering of any kind allowed within 150 feet during EV hours

In-Person Early Voting Local Elections:

- Cities and towns can choose to have in-person EV for local elections
 - If on same date as state primary, state election, or presidential primary, must have in-person EV for same hours
 - At least 2 registrars must recommend it
 - Board of selectmen, town council, or city council must vote to authorize
- Opt-in vote must be at least 5 days before start of EV and must include EV schedule
 - EV can't start before 17th day before and can't end after 2 business days before
 - Hours: usual business hours unless vote specifies otherwise
 - Location and EV schedule must be posted at least 48 weekday hours before start of EV

Other Changes:

- Poll workers:
 - Vacancies 6 weeks before election: appointing authority appoints
 - Vacancies 3 weeks before election: clerk appoints
 - Can fill vacancies without regard to party, voter registration status, or residence
- Police Officer Assignments
 - Board of selectmen, town council, or city council assigns police officers or constables to polling places
- Jail-Based Voting – Starting 2023
- Back-end Automatic Voter Registration – Starting 2023

EV and VRIS:

- EV Search
- EV Maintenance
- Additional Reminders

EV and VRIS EV Search:

- Select 9/6/2022 from 'Election Date' dropdown
- Search voter one of two ways:
 - Scan barcode:
 - Click into 'Voter ID' field. Cursor must be in 'Voter ID' field before scanning
 - Scan barcode
 - Search results display with voter information and voter highlighted
 - Search manually:
 - Enter at least one character for last name or street name, then 'enter' or 'Search'
 - Search results display with matching voters
 - Select voter record matching application to highlight record
- Once record is highlighted, select 'Create EV' to open EV Maintenance

EV and VRIS EV Maintenance:

- Date App Received: Auto-populate date EV created
- Mailing Address: Auto-populates with voter record mailing address
 - Can be edited or added based on application
 - If left blank, labels will automatically print using residential address
- State Election Checkbox: to create EV for state election, make sure box is checked
 - Current default: checked
 - Upcoming deployment default: unchecked
- Party
 - Voters in party: populates with voter party
 - Unenrolled/designations: select party from dropdown

EV and VRIS Additional Reminders:

- EV Search with barcode:
 - After closing EV Maintenance, select 'Search' or 'Clear' before next scan
- EV Scan
 - EV scan should ONLY be used to update ballot information or to create in-person EVs.
 - EV Scan doesn't allow you to:
 - Create EV for both state primary and election at same time
 - Verify residential address from application
 - Update mailing address

Commonly Asked Questions:

- Can a voter enrolled in a party request a different party ballot?
 - NO. You can send them the ballot for the party they are registered in OR
 - Contact the voter and have them submit an updated voter registration for the other party
- An unenrolled voter indicated they want a primary ballot but did not check a party box. How do we process it?
 - If a voter is unenrolled/in a designation and did NOT indicate a party, you cannot send them a ballot
 - You can attempt to contact the voter directly to clarify

Commonly Asked Questions:

- What if the voter didn't sign the application?
 - Can NOT send them a ballot
 - If not an AV or EV for November election, they will be sent another application in September
- Do we need to attach registrars certification to each application?
 - NO. When you receive applications by mail, you should timestamp them
 - When entering into VRIS, we recommend adding the initials of the person entering it and the date they entered it on the application itself

Commonly Asked Questions:

- What if voter is listed as inactive?
 - The voter will be automatically activated when you process the application for the voter
- What if the voter is flagged to show identification?
 - You must send the requested ballot to the voter, but you need to include notice to the voter that they must return a copy of their identification with the completed ballot
