## **Workshop and preparation of Outreach Document**

Commissioner Javier Luengo-Garrido pointed out that this meeting will be a working session. The last subcommittee outreach meeting a full document was created, with guidelines. Commissioner Luengo-Garrido noted that the subcommittee has gathered testimony from affected communities as well as advocates and invited the public to assist with the editing process.

The commissioners workshopped the testimonies document.

Community members Sean Donovan, Jose Adastrá, and Ya-Ping Douglass provided formatting and content suggestions.

Sean Donovan noted that a question should be added about individuals interacting with the police. His understanding is that police don't see distress and then react to it, they usually respond to crisis/distress calls. Sean noted that he knows some of the individuals that created the Brattleboro report, which was a result of very specific listening sessions. Sean concluded that it is important for people to have a way to remove their stories at any point.

Commissioner Javier Luengo-Garrido questioned how the Commission can deal with organizations that have benefited from the pervasive system and wondered how the Commission gets them to talk to the group because if the Commission recommends anything besides the status quo then these organizations will get less money than what they are already getting.

Commissioner Carol Owens pointed out that it seems that Javier is asking the question of how the Commission will explain to the community the phenomenon of soft policing. Carol concluded by saying that DCF has a mission to be concerned with the safety of all children in Massachusetts and how they do that is in part by a policing function and an investigatory function.
