She said sometimes folks are referred to Highland Valley Elder services as well. She said sometimes people have a need that doesn't match the agency.

Commissioner Nick Fleisher shared his screen and showed the draft of the committee's report.

Commissioner Nick Fleisher suggested people flag areas of particular passionate concern.

Commissioner Nnamdi Pole said he crossed some things because these are generic things that are about what the commission was asked to do, but not things that have to do with subcommittee recommendations.
