The polls will be opened at seven o'clock in the forenoon and closed at eight o'clock in the evening of the said day, and all such voters will in the several wards and precincts in which they are individually entitled to vote between said hours give in their votes for the Electors of President and Vice President, for Representative in Congress for the Second Congressional District, for Councillor from the Eighth District, for Senator in General Court for the Hampshire & Franklin District, for Representative in General Court for the First Hampshire District and for Sheriff of Hampshire County.

They will also give in their votes, "Yes" or "No" on the following questions:

Question No. 1 - This question is not binding.

Shall the state representative from this district be instructed to vote for legislation to create a strong presumption in child custody cases in favor of joint physical and legal custody, so that the court will order that the children have equal access to both parents as much as possible, except where there is clear and convincing evidence that one parent is unfit, or that joint custody is not possible due to the fault of one of the parents?

Question No. 2 - This question is not binding

Shall the state representative from this district be instructed to vote in favor of legislation that would allow the state to regulate the taxation, manufacture and sale of marijuana to adults 21 and older provided that sales outlets are state licensed, do not sell alcohol, and are not within 500 yards of a school?

Question No. 3 - This question is not binding.

Shall the state representative from this district be instructed to vote in favor of: (1) a resolution asserting that the campaign against terrorism should not be waged at the expense of constitutionally protected civil rights and liberties of Massachusetts residents; (2) legislation barring the use of state resources or institutions to carry out actions that violate constitutional rights, or actions such as racial and religious profiling, conducting secret investigations without reasonable grounds, and maintaining files on individuals and organizations without reasonable suspicion of criminal conduct; and (3) a resolution urging the Massachusetts Congressional delegation to vote to repeal provisions in the federal USA PATRIOT Act and other laws that infringe on civil rights and liberties?
