## R.22.143 A RESOLUTION In Support of a Federal Assault Weapons Ban

WHEREAS, the 1994 federal assault weapons ban was allowed to expire in 2004, AND

WHEREAS, scientific research demonstrates that unregulated access to guns results in a higher number of firearm fatalities, AND

WHEREAS, 25% of firearm deaths in the United States each year are of children<sup>1</sup>, AND

WHEREAS, people with a gun in their home are more than twice as likely to be killed by a gun than those who live in homes without guns, with disproportionately higher risks to women who are far more likely to be victims of gun-related intimate partner violence when living in a household with a gun owner<sup>2</sup>, AND

WHEREAS, research estimates that when the federal assault weapons ban was in effect, mass shootings were 70% less likely to occur<sup>3</sup>, AND

WHEREAS, limiting access to assault weapons and high-capacity magazines has a demonstrable impact on reducing mass shootings, with states with limitations experiencing mass shootings at less than half the rate of states without restrictions<sup>4</sup>, AND

WHEREAS, of all mass shooting incidents (shootings involving 4 or more victims)

between 2009 and 2018, assault weapons accounted for 76% of nonfatal injuries, AND

WHEREAS, survivors of gun violence with nonfatal injuries and their families face lifealtering outcomes, including:

- An average increase of \$2,495 per month on medical spending in just the first year
- A 51% increase in psychiatric disorders for survivors of gun violence
- A 12% increase in psychiatric disorders for family members of survivors
- An 85% increase in substance abuse disorders for survivors<sup>5</sup>

WHEREAS, on July 5, 2022, the American College of Physicians released a statement declaring that gun violence is a national epidemic that will require "using all the tools one would employ for an epidemic" in order "to keep our patients and our communities safe."

NOW THEREFORE BE IT RESOLVED, that the City Council of Northampton calls on our federal government and representatives to reinstate a ban on assault weapons and restrict the size of magazines that can be purchased, AND

BE IT FURTHER RESOLVED, that the City Council of Northampton supports a federal assault weapons ban as a necessary step, but only a first step, in addressing the public health crisis that gun violence of all types presents in our country, AND

BE IT FURTHER RESOLVED that the Administrative Assistant to the City Council shall send a copy of this resolution to: Congressman James P. McGovern, Senator Elizabeth Warren, Senator Edward Markey, President Joe Biden, Attorney General Merrick Garland, and Acting Director of the Bureau of Alcohol, Tobacco, Firearms, and Explosives Gary M. Restaino.
